AN ORDINANCE AMENDING CHAPTER 233-8 PEDDLING AND SOLICITING  
OF THE PENNSAUKEN CODE

Ordinance Amendment

Pennsauken Township Code, Chapter 233-8 Peddling and Soliciting

§233-6. License Required

Add New Section D. A canvasser and solicitor offering service to residential or commercial property owners for the purpose of securing a fire-damage building or structure must first obtain a license. It is unlawful for any person to engage in the business of a canvasser or solicitor within the corporate limits of the Township without first obtaining a license, pursuant to §233-7.

- (1) Once Licensed, each individual and/or business will be placed on a list, maintained by the Fire Marshal's Office, and furnished to the property owner, building owner, or their designee, for selection when services are needed.
- (2) Licenses must be renewed annually.

§233-8. Investigation; Records of License

Section A. (1)(d) Change "The Bureau of Fire Prevention" to "The Fire Marshal's

Office." Section A. (5) Change "The Bureau of Fire Prevention" to "The Fire Marshal".

Add New Section E. No public adjuster shall solicit the adjustment of a loss or damage occurring in this State from an insured, whether by personal interview, by telephone, or by any other method, between the hours of 6:00 P.M. and 8:00 A.M. during the 24 hours after the loss has occurred, pursuant to N.J.A.C. 11:1-37.13(c)

Add New Section F. No public adjuster shall enter into any contract or agreement, oral or written, with an insured, to negotiate or settle claims for loss or damage occurring in this State between the hours of 6:00 P.M. and 8:00 A.M. during the 24 hours after the loss has occurred, pursuant to N.J.A.C. 11:1-37.13(d)

WHEREAS, the New Jersey Department of Environmental Protection, Green Acres Program ("State"), provides grants and/or loans to municipal and county governments and grants to nonprofit organizations for assistance in the acquisition, development, and stewardship of lands for outdoor recreation and conservation purposes; and

WHEREAS, the Township of Pennsauken desires to further the public interest by obtaining total funding in the amount of \$978,178.50, in the form of a \$733,633.85 matching grant and, if available, a \$0.00 loan, from the State to fund the following project(s); Lena Skelly Transformation Project at a cost of \$978,178.50.

WHEREAS, the State shall determine if the application is complete and in conformance with the scope and intent of the Green Acres Program, and notify the applicant of the amount of the funding award; and

WHEREAS, the applicant is willing to use the State's funds in accordance with such rules, regulations and applicable statutes, and is willing to enter into an agreement with the State for the above-named project;

NOW, THEREFORE, the governing body resolves that:

1. Tim Killion or the successor to the office of Township Administrator is hereby authorized to:
  - a. Make application for such a loan and/or such a grant
  - b. Provide additional application information and furnish such documents as may be required, and
  - c. Act as the authorized correspondent of the above-named applicant.
2. The applicant agrees to provide its matching share to the Green Acres funding request, if a match is required, in the amount of \$244,544.65.
3. In the event the State's funds are less than the total project cost specified above, the applicant has the balance of funding necessary to complete the project.
4. The applicant agrees to comply with all applicable federal, state, and local laws, rules and regulations in its performance of the project; and
5. This resolution shall take effect immediately.

**BACKGROUND**

**WHEREAS**, on or about June 15, 2023, the Township of Pennsauken (hereinafter, the “Township”) awarded a contract for the establishment and construction of a new facility for the Public Library and Municipal Complex (hereinafter, the “Project”) to Terminal Construction Corporation (hereinafter, “Terminal”); and

**WHEREAS** the original contract sum for the Project was \$27,490,000; and

**WHEREAS**, during the course of the Project, a deduct Change Order for \$13,914.98 was approved, resulting in a new contract sum of \$27,476,085.02; and

**WHEREAS**, the Contractor has now reduced the total cost of the Work further, resulting in an additional deduct Change Order in the amount of \$436,719.53; and

**WHEREAS**, the Architect, Construction Manager and Contractor are all in agreement that the new proposed contract sum of \$27,039,365.49 is fair compensation for the work and services performed; and

**WHEREAS**, the Township has further determined that the proposed modification necessitates a change order to reflect the actual contract amount, and that approval of Change Order No. 3 in the amount of a decrease of \$436,719.53 to Terminal is necessary and appropriate.

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWNSHIP OF PENNSAUKEN, IN THE COUNTY OF CAMDEN, NEW JERSEY, AS FOLLOWS:**

(LEXA CONCRETE, LLC)**

WHEREAS, the Township Committee, by way of previous Resolution 2024-367 awarded a contract to Lexa Concrete LLC for the 2023 Road Improvement Program, same being more particularly described in specifications which are on file in the Office of Township Clerk and available for public inspection during regular business hours; and

WHEREAS, Douglas Johnson at Remington & Vernick Engineers, 2059 Springdale Road, Cherry Hill, New Jersey 08033, the Township's agent responsible for supervising the construction of said improvements for the Township of Pennsauken, has advised the Director of Municipal Services, by way of correspondence and Change Order Request No. 1 FINAL that the contract amount should be decreased from \$387,016.80 to \$356,802.71, decrease of \$30,214.09, and that said changes do not materially change upon the size, nature, or scope of the original project as described in the specifications; and

WHEREAS, Douglas Johnson at Remington & Vernick Engineers, 2059 Springdale Road, Cherry Hill, New Jersey 08033, the Township's agent responsible for supervising the construction of said improvements for the Township of Pennsauken, has advised the Director of Municipal Services, by way of correspondence and Change Order Request No. 1 that the contract timeframe be extended from ninety (90) days to one hundred sixty-one (161) calendar days, thereby shifting the completion date from June 15, 2025 to August 25, 2025, and that said changes do not materially change upon the size, nature, or scope of the original project as described in the specifications; and

WHEREAS, the Township Committee has reviewed the aforementioned request and desires to act favorably with respect to the same and to amend the contract accordingly and to approve the change order.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Pennsauken, County of Camden, State of New Jersey, as follows:

1. That the Township Committee, for the aforementioned reasons, hereby amends the aforementioned contract and decreases the contract amount from \$387,016.80 to \$356,802.71 in accordance with the terms and conditions of the aforementioned correspondence, said correspondence and request being attached hereto as Schedule A.
2. That the Township Committee hereby directs the Township Administrator and the Township Clerk to execute any contract documents which are necessary to effectuate the terms of this resolution, subject to review, revision and approval by the Office of the Township Solicitor.
