#### CONFERENCE / ITEMS OF DISCUSSION-

Juriu Matsuk- 815 Hylton Rd. asked the Township Committee for permission to have a used car dealer license. He is a Porcshe specialist. He does restorartions, buying, selling and collecting. Mr. Matsuk would be keeping everything in a warehouse. All sales would be done on line. He is looking at a property on Hylton Rd and one on Browning Road. He prefers the Hylton Rd. property as it is easy to get to for him and others. Mr. Matsuk stated that he would have a maximum 15 cars at most. Also he would not be displaying any cars outside of property and does no painting on site.

#### This May Move Forward

#### 1. MPWC Presentation

The following were present from the Merchantville Pennsauken Water Commission to make a presentation to the Township Committee- Chief Operating Officer Michael Saraceni, Superintendent Craig Campbell, Mr. George Piperno, MPWC Commissioner and former MPWC President Bernie Kofoet.

Mr. Saraceni made the following presentation to the Township Committee;

Good evening Mayor Taylor, members of Township Committee, (Mr. Padalino, Mr. Grochowski, Mr. Carr, Mr. Cardwell) and thank you for carving out time from your busy agenda to entertain these comments.

As you are aware, the Commission has asked me to maintain the tradition of providing both local governments a brief overview of annual operations of the Water Commission. In the interest of brevity, I have reduced the highlights to the critical benchmarks and will remain available afterwards to answer any and all questions that you might have.

#### Summary of Events

It is the intent of the Commission to maintain its commitment to the residents/rate payers that we serve by keeping a close and watchful eye on our aging infrastructure, completing ongoing preventative maintenance while performing upgrades and replacement of critical infrastructure within budgetary constraints. It is with that in mind that we strive to keep our operating costs as low as possible while re-investing in capital needs. We espouse team involvement in identifying strategic priorities, working closely with the Commissioners while harnessing the talented personnel on the payroll to achieve our goals.

#### **Projects**

The ongoing efforts are focused on four (4) primary areas; main replacement, meter replacement, Elevated Water Tank maintenance and treatment technologies. In 2014, we;

- Replaced deteriorating water main on Plymouth Place/Hinchman Avenue, significantly reducing, if not eliminating, service compromises that have long-plagued that artery.
- We are next targeting Essex, Greenleigh and Evergreen Avenues plagued

- Meter Replacement Program Service Techs,/aggressive effort –over 1,700 meters;
  - Average of 140 per month (Up by average of 15/month over 2013))
  - 12 Books Done 21/89 25% completed, 4 in progress (7,330/14,826 year 50%)
  - Several books can now be read in a fraction of the time it would take to do manually
- The Park Avenue Tank was completely overhauled (\$2.5 M) (Largest 3MG) and distribution system at the plant re-engineered (in-house) to increase its effectiveness and efficiency.
  - The National Highway and Clements Ave Tanks were power washed and had their finishes touched up.
- We upgraded Browning Road Treatment Plant through adjusted filter rates following filter media replacement/upgrade. Switched media to Greensand to increase effectiveness (Reduced chemicals/costs, improved water quality, increased flow capabilities into water system)
- We fully-demolished the Delaware Gardens treatment Plant, decommissioned many years ago. We will be re-routing water main around the property and the entire lot has been completely purged of treatment/pumping equipment/structures and fully-restored to its natural state.
- Dudley Avenue a flow deficiency was identified that could have seriously compromised fire operations. Once identified, sections of main were extended, creating a loop; that significantly increased flow capabilities in that section of our franchised area.
- Geographic Information Systems ongoing digital data project to fully-digitize MPWC infrastructure. This year adding hydrants, blow-offs & 2,500 curb stops to our base map taking the information from experiential wisdom employees' knowledge/MPWC records, creating an MPWC database for asset management and control.
- Through inter-local agreement, entered new Interconnect Agreement with City of Camden alternative water supply criteria mandated by the NJDEP for the City.
- Renewed annual subscription to Swiftreach, Reverse 9-1-1 (just under \$10,000) system which is now a common local government service for trash and other public works projects as well for the public safety through the police department.
- We authorized a 4% water rate increase for 2015 designed to minimize impact to the majority of customers, as follows; the average MPWC residential user uses 2300 cubic feet per quarter or 17,204 gallons billed at \$55.00/quarter. At NJAW Rates, that would be \$141.84, roughly 2.5 times higher. A large commercial user can be charged \$95,153.05 per quarter, roughly 1.5 times higher.

#### **Operations**

- Right-sized table of organization on the operations side eliminated one Assistant Superintendent's position, created the position of Field Supervisor filling two positions. This adjustment turned positive dividends as we also embarked on an aggressive cross-training program with all field employees, increasing efficiency and effectiveness.
- We replaced our leased fleet, assumed vehicle maintenance saving \$800/month vehicle
- Successful Compliance Inspections by NJDEP and NJDOH
- Clean 2013 Financial Audit By Auditors
- Water Quality Complaints Training, Customer Support Center, Data/Info Management plus construction data analysis and management – crosstab data – causal relationships.
- Participation in Annual Holiday Parade
- Transitioned to paperless communications with Commissioners through use of electronic devices.
- Addressed neighbors' concerns regarding Solar Fields at Browning Road

- Re-appointment by Merchantville Borough of Patrick Brennan 5 year term July 1, 2014
- Bernhard Kofoet retired after completing 26.5 years of loyal and dedicated service to the Commission welcoming George Piperno to the team as we speak.
- In July, Angela Waldron attained Qualified Purchasing Agent State Certification.
- Back Hoe Replaced was received, upgraded to include Jack Hammer attachment
   Time/Money Savings Safety of Personnel
- Facebook Page MPWC entered social media to better serve the communities
- Summer Help Program continuing development of young adults entering the workplace- young adults provided many areas of maintenance, repair and support.

#### Three (3) Critical Initiatives/Events

- 1) The MPWC requested that the New Jersey State Police Vulnerability Assessment Unit conduct an assessment of all MPWC facilities, as the MPWC properties fall under the protected critical infrastructure classification in the State. The report was comprehensive and the Commission took a proactive approach. As the inspections started early in the year, as areas of concern were identified in draft, they were being addressed/corrected as they moved forward. Receiving the final report at the end of 2014, many recommendations have already been implemented, including the addition of cameras and lighting upgrades with the rest are being programmed for 2015.
- 2) On Friday May 9<sup>th</sup>, 2014, in the early hours, a breach in a hi-pressure/16" backwash/discharge line occurred beneath the floor inside the Park Avenue Plant causing significant damage to the building and crippling the operation. Upon occurrence, the Operator on duty made quick notification to key personnel who were able to isolate the leak and shut it down, causing minimal disruption to service in the vicinity of the plant. The entire facility was flooded with water, gravel and mud knocking out computer and communications systems and the floor/building sustained extensive damage. What followed;
  - Notifications to key personnel, agencies, departments, communities, insurance carriers
  - Engineer and Water management personnel quickly diagnosed the source and excavated the area to expose the leak.
  - After inspection by claims adjusters, township and MPWC officials, MPWC personnel repaired the damage to the underground piping and the system was operational within 12.0 hours.
  - Plant Operators were immediately relocated to the Westfield Avenue Office and restored phone/computer services for our customers.
  - MPWC Treatment Specialists were placed on 4-hour inspection cycles to all plants, treatment systems, tanks and facilities, as the shutdown to SCADA monitoring left the operators blind.
  - Saturday May 10<sup>th</sup>
    - Subcontractors (electrical, control systems) assisted MPWC Engineer with diagnosing and assessing all treatment/control systems to restore operational readiness.
    - Restoration contractor began removing all water, gravel and mud from the building.
  - Sunday, May 11<sup>th</sup>:
    - o By 1:00 PM, all Plant Systems were fully functional
    - Computers/Communications restored as operational at the Plant
    - o Plant Operators resumed operations at the facility
  - End of June, 2014:
    - o The entire facility was completely restored and refinished.
    - All damaged sheet rock replaced and repainted

- o All damaged floor coverings (tile/carpet) removed and replaced
