TOWNSHIP COMMITTEE MEETING
April 19, 2017**

A Meeting of the Pennsauken Township Committee was held on Wednesday, April 19, 2017 in the caucus room at the Township of Pennsauken Municipal Building, 5605 N. Crescent Blvd. Pennsauken, NJ 08110.

Mayor McBride called the meeting to order at 5:30 pm, the roll was recorded as such:

PRESENT: Mayor Betsy McBride, Deputy Mayor Killion, Committeeman Taylor, Committeeman Figueroa and Committeeman Orth

Also present were Township Administrator John Kneib, Township Clerk, Gene Padalino, Deputy Clerk Pamela Scott-Forman, Township Attorney Michael Joyce and Economic Development representative Larry Cardwell.

Roll call was followed by the Pledge to the Flag with a moment of silence.

Mayor McBride announced that the Meeting was being held in compliance with the "Senator Byron M. Baer Open Public Meetings Act".

Committeeman Figueroa moved a motion to approve the minutes on the agenda; which was seconded by Committeeman Orth. An affirmative 5/0 voice vote was recorded

Deputy Mayor Killion moved a motion to acknowledge the bid opening; which was seconded by Committeeman Figueroa. An affirmative 5/0 voice vote was recorded

Committeeman Taylor questioned if the area on Park where there was work done by PSE&G would be paved also.

Administrator Kneib replied yes and that the Township Engineer had walked the Township with PSE&G. All street will be replaced to original state; asphalt with asphalt and concrete with concrete.

ORDINANCE NO. 2016:16 REFUNDING BOND ORDINANCE PROVIDING FOR THE REFUNDING OF THE TOWNSHIP'S OUTSTANDING CALLABLE GENERAL OBLIGATION BONDS, SERIES 2008, DATED SEPTEMBER 9, 2008; AUTHORIZING THE ISSUANCE OF UP TO \$5,100,000 OF GENERAL OBLIGATION REFUNDING BONDS OF THE TOWNSHIP OF PENNSAUKEN, COUNTY OF CAMDEN, NEW JERSEY, TO FINANCE THE COSTS THEREOF; MAKING CERTAIN DETERMINATIONS AND COVENANTS IN CONNECTION THEREWITH; AND AUTHORIZING CERTAIN RELATED ACTIONS IN CONNECTION WITH THE FOREGOING

BE IT ORDAINED by the Township Committee of the Township of Pennsauken, County of Camden, New Jersey (not less than two-thirds of all the members thereof affirmatively concurring), pursuant to the provisions of the Local Bond Law, Chapter 169 of the Laws of 1960 of the State of New Jersey, as amended and supplemented ("Local Bond Law"), as follows:

Section 1. The Township of Pennsauken, County of Camden, New Jersey ("Township"), is hereby authorized to refund all of its outstanding callable General Obligation Bonds, Series 2008, dated September 9, 2008, in the aggregate principal amount of \$4,565,000 (consisting of: (i) \$345,000 Golf Course Utility Bonds; and (ii) \$4,220,000 General Improvement Bonds), and maturing on September 1 in the following years and principal amounts (collectively, the "Callable Bonds"):

The exact principal amount of Callable Bonds to be refunded (which may be less than all of the Callable Bonds) shall be determined pursuant to a resolution adopted by the Township Committee by not less than two-thirds of all the members thereof.

Section 2. To effectuate the refunding of up to all of the Callable Bonds, negotiable general obligation refunding bonds of the Township are hereby authorized to be issued in one or more series in an aggregate principal amount not to exceed \$5,100,000 ("Refunding Bonds"), pursuant to the Local Bond Law. The maximum principal amount of Refunding Bonds to be issued and other terms thereof shall be determined pursuant to a resolution adopted by the Township Committee by not less than two-thirds of all the members thereof.

Section 3. An aggregate amount not exceeding \$115,000 for the items of expense listed in and permitted by Section 51.b. of the Local Bond Law, N.J.S.A. 40A:2-51.b., has been included in the aggregate principal amount of the Refunding Bonds authorized herein.

Section 4. The purpose of the Refunding Bonds is to effect an interest cost savings for the Township.

Section 5. Each Refunding Bond authorized herein shall be designated, substantially, "Township of Pennsauken, County of Camden, New Jersey, General Obligation Refunding Bond, Series 20___" and shall be in the form prescribed and permitted by the Local Bond Law, as Bond Counsel may advise, and as the Township shall approve.

Section 6. The Refunding Bonds may be sold at public or private sale pursuant to a resolution of the Township Committee adopted by not less than two-thirds of the full members thereof.

Section 7. The supplemental debt statement provided for in Section 10 of the Local Bond Law, N.J.S.A. 40A:2-10, was duly filed in the office of the Township Clerk prior to the passage of this refunding bond ordinance on first reading and a complete executed duplicate original thereof has been filed in the Office of the Director of the Division of Local Government Services in the Department of Community Affairs of the State of New Jersey.

Section 8. A certified copy of this refunding bond ordinance as adopted on first reading has been filed with the Director of the Division of Local Government Services in the Department of Community Affairs of the State of New Jersey prior to final adoption, together with a complete statement in the form prescribed by the Director and signed by the Chief Financial Officer of the Township as to the outstanding indebtedness to be refunded by the issuance of the Refunding Bonds.

Section 9. This refunding bond ordinance shall take effect twenty (20) days after the first publication thereof after final adoption, as provided by the Local Bond Law.

Administrator Kneib explained the callable bonds and long term interest bonds.

Administrator Kneib replied that it fluctuates with higher interest but as of right now it is 1.75%

SECOND READING/PUBLIC HEARING (PUBLIC MAY COMMENT)

ORDINANCE NO. 2017:05 AN ORDINANCE TO AMEND THE CODE OF THE TOWNSHIP OF PENNSAUKEN CHAPTER 299 ENTITLED VEHICLES AND TRAFFIC TO ADD A “DO NOT BLOCK” BOX ON REMINGTON AVENUE

WHEREAS, the Township Police Department has recommended that a Do Not Block designation be installed on Remington Avenue at the Pennsauken High School parking lot driveway; and

WHEREAS, the Township Police Department has determined that traffic congestion occurs during school drive time due to the traffic signal at Remington Avenue and Hylton Road; and

WHEREAS, said traffic congestion can be alleviated by striping a “Do Not Block” box in the westbound lane of Remington Avenue along with the appropriate warning signage.

NOW, THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Pennsauken in the County of Camden and State of New Jersey as follows:

Section 299-18 is amended to add the following location:

Remington Avenue westbound side for the full length of the driveway for the Pennsauken High School.

Appropriate striping and signage shall be provided at this location in conformance with the Manual on Uniform Traffic Control Devices for Streets and Highways.

All ordinances or parts of ordinances in conflict or inconsistent with the provisions of this ordinance are, to the extent of such inconsistency, hereby repealed.

This Ordinance shall take effect in accordance with law.

Ms. Diane Johnson of 45th Street questioned what the resolution actually means.

Administrator Kneib explained what the resolution actually does, by stopping anyone from actually stopping usually at a stop light allowing cross traffic to move.

PUBLIC COMMENT

Mayor McBride stated that in honor of Earth Day a Township Shredding event would be taking place on Saturday, April 22nd at the Middle School on Park Avenue between 9-noon. She also stated the Shade Tree Commission would be sharing stick/shoots (tree saplings) with anyone who would like one and that wild flower bombings are being made for planting in public areas.


