

**MINUTES
TOWNSHIP OF PENNSAUKEN
TOWNSHIP COMMITTEE MEETING
SEPTEMBER 17, 2020**

The Committee Meeting of the Pennsauken Township Committee was held via ZOOM electronic participation on Thursday, September 17th, 2020.

The Meeting was called to order by Mayor Killion at 6:03 pm. Who also gave an update on the number of COVID cases within the Township. Mayor Killion expressed his thoughts, concerns and prayers for families affected by the virus and for the families who have lost loved ones. He continues to stress the importance of wearing your mask and social distancing. He also asked for prayers for the families caught in the devastating fires in California.

Mayor Killion called for the Salute to the Flag followed by a Moment of Silence and announced the "Senator Byron M. Baer Open Public Meetings Act" keeping the meeting in compliance with state laws.

AN ORDINANCE AMENDING THE CODE OF THE TOWNSHIP OF PENNSAUKEN CHAPTER 299 ENTITLED "VEHICLES AND TRAFFIC" (829 Engard & 4620 Roosevelt)

BE IT ORDAINED by the Mayor and Township Committee of the Township of Pennsauken, in the County of Camden, State of New Jersey, as follows:

Chapter 299-57 "Restricted Parking Zones in Front of Residences: is hereby amended to ADD the following:

1. Handicapped Parking Signs located at 829 Engard Avenue beginning 73 feet north from the northwest corner of Engard Avenue and Day Avenue and continuing 22 feet north.
2. Handicapped Parking Signs located at 4620 Roosevelt Avenue beginning 475 feet east from the southeast corner of Terrace Avenue and Roosevelt Avenue and continuing 22 feet east.

All Ordinances or parts of Ordinances inconsistent or in conflict with the provisions of this Ordinance are hereby repealed.

This Ordinance shall take effect upon due publication and final enactment as provided by law.

WHEREAS, the Federal Highway Administration (FHWA) authorized Transportation Alternatives Federal-Aid funding up to an amount of \$195,891.98, for the Pennsauken-Merchantville Multi-Use Trail; and

WHEREAS, this authorization was based on the scope of work and budget agreed upon by the Township of Pennsauken and the NJDOT Division of Local aid; and

WHEREAS, the Township entered into a Professional Services Agreement with McCormick Taylor, Inc. for Preliminary Engineering, Final Design and Construction Engineering Services for this project; and

WHEREAS, The National Register of Historic Places (NRHP) eligible Camden and Burlington County Railroad Historic District is situated within the construction footprint of the proposed undertaking. The original 1848 railroad alignment is situated within the project area, the elements of which may still be present; and

WHEREAS, it is necessary for the Township to execute an Agreement Modification in the amount of \$3,840.93 to the Federal Aid Agreement for McCormick Taylor to prepare an Archaeological Monitoring Plan as requested by the New Jersey Historic Preservation Office; and

NOW THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Pennsauken that the Township Administrator and Clerk are authorized to execute the attached Federal Aid Agreement.

Committeewoman McBride questioned the number of community meetings and if there had been any opposition to the feasibility study. She also questioned if it would be caged lighting.

Economic Development - Mr. Larry Cardwell presented the following...

A&J Landscaping – Derousse Ave Block 1005, lot 3 (no address) the second lot from the corner of River Road & Derousse Ave. A&J Landscaping would like to purchase this vacant lot to store equipment from their business. They would clean and landscape the newly acquired land.

This will need zoning board approval.

*****Committee is okay with moving forward***

Herbal Life – 5509 Westfield Ave (The rear unit) would be used as an office for an Herbal Life business for counselling and support to new members.

*****Committee is okay with moving forward***

JMJ Warehouse Associates LLC – 8501 River Road formerly Stech LLC. The business and the building are changing hands. The use will remain as a warehouse for Lyons and Sons who are purveyors of cocoa products and beans.

*****Committee is okay with moving forward***

Change of owner – 8600 River Road formerly part of Aluminum Shapes. The use will be a warehouse, they are searching for a tenant.

*****Committee is okay with moving forward***

PUBLIC COMMENT

Linda Rubiano of Chestnut Street questioned the movement on Two resolutions she presented to Committee at a previous meeting.

Mayor Killion suggested the resolutions be forwarded to our environmental commission. Committee will then discuss how we will move forward.

Committeewoman McBride questioned if this is just a letter in support? "I believe it is a worth while cause." She commented the Environmental commission meets on Monday. Please get the zoom information from our Administrator.

Rima Aboharb of Cedar Avenue spoke about the PYAA ban of the President Phil Morgan, Coach Dave and Coach Darryl. These men do so much with and for our children. Our kids love them and there is no reason for PYAA to continue without them. She asked that they please rethink your position.

Mayor Killion thanked Ms. Aboharb for her comments. He continued by explaining there was a very serious incident that happened and Committee's responsibility to keep 36,000 residents safe; which is first and foremost. The safety and not wanting to hurt the kids and their opportunity to play was in the forefront of Committee's decision. Mayor Killion informed the residents that there is a process and that they are in the middle of an investigation as well as a criminal investigation also by the Camden County Prosecutors office. He pointed out the following

- Team invited to play from a State on the COVID restricted list
- Proper procedures where not followed
- No insurance secured
- No approval given
- Allowed a previously banned team play Tri County Owls
- Concern of residents in the area
- Poor decision which effected the entire Township

He thanked her for sharing her sentiments

Marilyn Acoveria of Velde Avenue – stated she was speaking for PYAA and that her son's participation with the coaches and football team are vital. She feels the actions towards the coaches is too harsh. "If you really cared about the kids you'd let them back, they are vital to the kids who don't have fathers."

Mayor Killion responded there is a lot to complete the process and right now they have to be barred as we work through the investigation.

Tanya Beeman of Green Avenue complained about the trash pick up and the horrible job they are doing. Will we be changing back to the previous company and if any other complaints have been levied.

Deputy Mayor DiBattista responded that some discussions have been had between our attorney's and their attorneys. "They are on a short leash." We are going through the proper channels to remove them.

Mayor Killion asked if she has any other problems to contact Public Works for tracking. They have gotten a little better since we spoke to them in the last month or so.

Tiffany Wilson of Riverview Road – understands the accountability concerning PYAA but what happened, happened between adults. She questioned how is it that they have an indefinite suspension and never had a suspension before?

Deputy Mayor stated that there has not been an indefinite suspension but trying to get through finding what role anyone played in this incident.

Jose Calves, Esq. Parker McCay

We don't know who gave the permission to play on the facility and the process. It was not the proper facilities. There was an appeal process for them to follow; which they can still submit if they want to challenge the decision.

Acting Administrator Palumbo commented no letters had been received. He also read a couple comments in the chat box about shootings and fights are typical at youth games.

Mayor Killion reiterated that we will not tolerate, fights or violence at any of your events. We can't be desensitized that shooting are okay. We are looking at everything to make everything safe and the quality of life is better in that area.

Arlethia Brown of Boulevard Avenue questioned the EPA concern and challenges about the water and the possibility of contamination. She questioned if this was the correct setting. Her major concern is the light industrial businesses coming up in the Delair section of the Township. She questioned the solar panels at World Harvest Community Church. What is the Township doing to help the residential area?

Mayor Killion commented he has a meeting set up for next Tuesday night with the church, residents and the solar company. Morrisville community group has been engaging them (Solar) since day one.

Committeewoman McBride stated the EPA required to contact all resident from the closing of the puchack well. She will contact the Chair of the Environmental Commission to have the information at the meeting on Tuesday. The truck traffic was redirected to Sherman Avenue if trucking companies are using Derousse Avenue the police should be notified. Commented the EPA should come and give a presentation to the residents.

Committeeman Dyer thanked her for bringing it to Committee's attention.

Kira Lasisi of Park Avenue – fights and shootings are becoming commonality on youtube. Pennsauken is a high crime rate with 69.8 higher rate than other locations. She commented there has never a police presence and questioned what the Township has done to make Pennsauken safer? She referenced the fatal shooting that took place on 48th and Westfield Avenue. She suggested inter action with the youth of PYAA and the police department.

Mayor Killion introduced Chief Nettleton

Chief Nettleton stated that 2 years ago he made a presentation to Twp. Committee to increase man power. There are currently 8 in the Academy and 7 in field training. He commented on the participation in Pennsauken High community events. They have a lot more planned but have been side tracked due to the pandemic. Chief Nettleton also commented they had no information about an event going on that day.

Rema Abohard of Cedar Avenue – questioned if the coaches could be at the home games?
“We need them.”

Mayor Killion replied as of today and moving forward they can not be at the fields until after the investigation has been completed and we have a final determination.

Mayor Killion replied there is still a process we are going through and information we are gathering. He replied to the written questions. Committeeman Dyer and the Mayor have met with and will work something out to have an open meeting with PYAA member when they have answers.

Erica Cook of Terrace Avenue questioned if there will be police presence at the PYAA games going forward and if the police will come do safety workshops with the youth of PYAA?

Chief Nettleton commented absolutely if they are asked they never say no. He also responded to a question about police on suspension being allowed to work on minor infractions.

Committeeman Dyer thanked the Mayor for handling the questions. He also commented on the importance of Coaches and that the situation is unfortunate. The process is working its self out. We ass adults have to look back and make sure we get this right. What we do is setting an example of what they have to do when they grow up. Believes we can sit down as adults and can get this nightmare scenario taken care of. Committee vowed the decision they come to does not impact the kids.

Committeeman Dyer moved to close the floor to the public
Deputy Mayor DiBattista seconded the motion
An affirmative 4/0 vote was recorded

COMMITTEE COMMENTS

Mayor Killion – spoke of the voting drop box, now placed at the municipal bldg. and explained the mail in vote process. He asked everyone to stay positive and continue to wear your face mask and practice social distancing.

Deputy Mayor DiBattista – thanked all the residents and the support for the coaches. We need to keep an open dialogue like this. Saturday we will be hosting a car show parade on Saturday the 19th due to the pandemic other than the usual car show.

Committeewoman McBride – thanked everyone for coming out and the passion of the EPA. The last 2 weeks to prepare for the Census. September 24th parking lot to help with drive through Census surveys. Large food distribution on October 2nd at the Soccer field complex beginning at 10:30 am

Committeeman Dyer – thanked everyone for coming out (55). Prayer to everyone impacted by COVID because it's not over yet. We need to continue to keep safe. Congratulations to Committeewoman Rafeh. Our job as adults is to do our best for our kids. "We're gonna get it right!"

WHEREAS, matters under discussion will not be disclosed until the need for confidentiality no longer exists; and
