# CONFERENCE / ITEMS OF DISCUSSION-

Discussion of 7300 Rt. 130-Industrial Park

Mayor Killion asked several questions of Economic Development & Zoning representatives of the Township and read a letter from the Code Enforcement Office concerning 7300 Business Park located at 7300 Rt. #130. He commented about unit #18 specifically with engines being revved and the selling of used cars without a license. Mayor Killion continued with the Township continuing to receive emails about trash and excessive noise.

Mr. Cardwell stated that Code Enforcement went with a representative form DMV who told them to cease and desist because of no license to sell used autos

Mayor Killion asked if the owner was present

He was not, Mr. Richard Shore of Flowertown, PA stated he was the property manager and that the owner is in New York; he is at the property about once a week but not before 7 am of after 7 pm. When asked he commented that he had no knowledge of sales but that there was a number of exclusive issues. He also commented that he had previously spoken to the tenants about the noise.

Mayor Killion commented that not enough is being done to be good neighbors with the residents at this location. Mayor Killion stated that is needs to be corrected ASAP and that he wanted the Zoning Officer, Code Enforcement, Fire, Police and Economic Development there in the morning writing ticket or violations everyday there after until it is corrected. Specifically he wanted from the Police parked cars without tags vin #'s checked and those without tags towed; from the Zoning Officer each unit checked for zoning and what type of business and business name for each unit; Fire Department any fire violations; Code Enforcement any and all violations.; these reports are to be written and turned over to the Administrator. "Any business that can't respect the residents may be disrespecting other ordinances also"

Mr. John Perese commented that the car noise hasn't happened in a while but there is a lot of load banging enough to jolt you up out of a deep sleep. Not sure but it could be trash pick-up.

Mr. Shore commented that each unit is responsible for their own trash removal.

Mayor Killion reiterated that Pennsauken tries to be business friendly but its first commitment is to the neighbors and reminded Mr. Shore they would be there in the morning.
